After starting her United Way journey as a volunteer in 211, Karen Kallerud served a record-setting 14 years as a Loaned Executive. In that role, Karen combined her passion for United Way's mission and concern for our community with very persuasive sales skills. She continues to volunteer for the annual campaign, specifically calling on new businesses and outreach for corporate gifts as an Account Executive. Karen's fantastic relationships with area companies has resulted in thousands of dollars of in-kind gifts, too, securing coupons for everything from oil changes to frozen custard.

She also served on the Former Loaned Executive Reunion Committee to celebrate 40 years of the program during United Way's Centennial. Karen is the "Queen of Thank Yous" writing hundreds of cards to individual donors and business leaders for their United Way support.

Beyond the workplace campaign, she has volunteered for Women United and helped plan the annual fundraising event; served on the Community Volunteer Awards Committee as a member and judge and is a mentor for each new class of Loaned Executives, often bringing in baked goods along with words of wisdom and encouragement.

Karen leads by example as a generous and thoughtful United Way Lead United and Women United Donor. She and her husband Jim have a named fund in our United Way Foundation as well as they support our mission for generations to come. Karen is the definition of a compassionate and caring person who inspires those around her to be a part of the change.

## **COLLABORATION AWARD**

#### **Saving Our Babies**

In 2018 the Dane County Health Council (DCHC), a coalition of healthcare providers, government and nonprofits, set out to eliminate the racial birth disparities impacting Black mothers and babies in Dane County. By committing to a single priority, DCHC paved the way for what today has become a partnership between health systems and community organizations that is yielding positive gains and demonstrating the power of collective impact on solving a public health crisis.

Under the umbrella of the Saving Our Babies initiative, ConnectRx Wisconsin has emerged as a revolutionary solution to reducing health and social needs risks of Black pregnant women and birthing persons served through local hospitals and clinics. Through a wrap-around service delivery model designed by initiative

partners with input from more than 300 Black community members, ConnectRx Wisconsin deploys a dual workforce of clinic- and community-based health workers and trained doulas to support patients' health in a number of ways. Referrals are made for housing, food, financial assistance and more – all factors that foster positive health outcomes for mother and child.

It utilizes a social determinants of health screening tool collaboratively developed by the local partners, which is embedded in the electronic health record system to screen all local pregnant patients. An initial evaluation showed that 90% of babies born with doula support reached optimal gestational age, and an impressive 84% were born at a healthy birth weight, addressing a critical factor in reducing Black infant mortality rates.

#### **Summit Credit Union**

In 2024, Summit Credit Union showed outstanding commitment to community engagement through their support of United Way of Dane County's affinity groups. Summit employees contributed active participation in Lead United, Women United and LINC, hosting multiple events throughout the year. Summit Credit Union demonstrates their strong leadership in community involvement by providing a Loaned Executive for the fall. New this year, Summit hosted an opportunity for employees to get involved in the community with Women United at Work to bring engagement to their ERG members.

#### Women United Council for Women United at Work

In 2024, Women United Council raised nearly \$100,000 to advance women's financial security, a cause they embraced as their new focus to create lasting change for women in Dane County. Demonstrating their commitment to uplift all women, they launched Women United at Work, a network designed to bring together local women's Employee Resource Group leaders, fostering a collaborative space for sharing best practices and strengthening career development. Through their innovative and purpose-driven approach, the Women United Council continues to create meaningful opportunities for women to lead – both in their careers and in their community.
